DURING THE FY 23-24, BRIDGE OF HOPE GREATER DENVER PARTNERED WITH 19 FAMILIES WHO WERE FACING HOMELESSNESS IN THE GREATER DENVER AREA. IN TOTAL, 19 SINGLE MOTHERS AND 50 CHILDREN WERE SERVED. THESE FAMILIES BENEFITED FROM RENTAL ASSISTANCE; PROFESSIONAL SUPPORT FOCUSED ON BUDGETING, CAREER PLANNING AND LIFE SKILLS; AND A NETWORK OF VOLUNTEERS. THIS COMBINATION OF RESOURCES HELPED FAMILIES TO STABILIZE AND EVENTUALLY TRANSITION FROM SURVIVING TO THRIVING. IN FY 23-24, 4 FAMILIES RECEIVED EDUCATION, 16 FAMILIES INCREASED THEIR INCOME, FAMILIES PAID OFF \$15,000 IN DEBT AND 7 FAMILIES GRADUATED TO SELF-SUFFICIENCY. OVERALL, 100% OF THE GRADUATES MAINTAINED STABLE HOUSING AND EMPLOYMENT AFTER EXITING THE BRIDGE OF HOPE PROGRAM.
