IN TOTAL, 25 SINGLE MOTHERS AND 53 CHILDREN WERE SERVED. THESE FAMILIES BENEFITED FROM RENTAL ASSISTANCE; PROFESSIONAL SUPPORT FOCUSED ON BUDGETING, CAREER PLANNING AND LIFE SKILLS; AND A NETWORK OF VOLUNTEERS. THIS COMBINATION OF RESOURCES HELPED FAMILIES TO STABILIZE AND EVENTUALLY TRANSITION FROM SURVIVING TO THRIVING. IN FY 22-23, 6 FAMILIES RECEIVED EDUCATION, 19 FAMILIES INCREASED THEIR INCOME, FAMILIES PAID OFF \$44,500 IN DEBT AND 13 FAMILIES GRADUATED TO SELF-SUFFICIENCY. OVERALL, 92% OF THE GRADUATES MAINTAINED STABLE HOUSING AND EMPLOYMENT AFTER EXITING THE BRIDGE OF HOPE PROGRAM.
